

Do I Need an Appointment If you are between the ages of 1820 you will also have to complete an approved driver's education course if you have not yet done so. However, exceptions can be made for applicants between the ages of 16 and 17 if they have completed a driver's education course, practiced driving for at least 50 hours, and passed the written, vision, and driving exams. These documents are arranged into four groups A, B, C, D and you will need one from each group—except group D, for which you will need two. You will be asked to execute several common maneuvers during your driving test—including checking vehicle controls and mirrors, parking, driving in reverse, and making a three point turn. Similarly, applicants aged 16 to 17 who are looking to obtain a Class D license will also have to undergo a driver's education course. Many Illinois public schools offer driver's education courses to help their students meet this requirement.

In the permit phase phase one, drivers must be at least 15 years old and should always have a licensed driver age 21 or older in the vehicle with them. They are not allowed to drive from 10 p.m. to 6 a.m. Sunday through Thursday and 11 p.m. to 6 a.m. on Saturday and Sunday. Phase two, also known as the initial licensing phase, requires drivers to remain convictionfree for the six months before this phase. Drivers in this phase are not allowed to have more than one passenger under the age of 20 in the vehicle at a time, unless they are a sibling or other family member. The driving test will require you to perform ten driving maneuvers. You can find a complete list of these maneuvers in the Illinois Rules of the Road handbook. If you subsequently fail those two attempts you will be required to pay another fee before trying again. Unlike many states, Illinois will normally allow you to retake your test on the same day you failed it, if possible. To prepare for the driving portion of your exam, you should spend time practicing the ten required maneuvers also listed in the Illinois 2014 Rules of the Road handbook. Keep in mind that you will have to pay this fee again if you fail three attempts at your driving test. As with the Class D license, you will need to provide

documentation proving your identity and residency within Illinois. If you are under 18 you will also need permission from a parent or guardian. If you're renewing a license that has been expired for longer than a year, or if you're applying for reinstatement after a suspension, you may have to retake the written exam in order to obtain your license. You must be at least 16 years of age, have held a permit for at least nine months, have logged a minimum of 50 hours including 10 at night of supervised driving time, have completed a stateapproved driver education program, and pass the three parts of the driver's license exam to apply for an initial license. If you are at least 18 years of age but under 21 years of age and have never been licensed or completed an approved high school or commercial school driver education course, you must complete a sixhour adult driver education course through a Secretary of Statecertified adult driver education provider before you may apply for a license. New Illinois residents with a valid outofstate license have 90 days to exchange it for an Illinois driver's license. You will be required to pass a written test, and possibly a drive test. In Illinois, you must have a valid Illinois license, successfully complete a motorcycle training course approved by the Illinois Department of Transportation, and pass a motorcycle examination to apply for a motorcycle classification. If you are at least 18 years of age and have successfully completed a motorcycle training course approved by the Illinois Department of Transportation, you are not required to take any motorcycle examinations to apply for a motorcycle classification. If you are under 18 years of age, you must have successfully completed an approved driver education course, successfully completed an approved Motorcycle Rider Education Course, and passed a written test to apply for a motorcycle instruction permit. You must have held a CLP for at least 14 days and pass a skills test to apply for a CDL.

Teens can take the test if they are at least 16 years old and have successfully completed a stateapproved drivers education course. If theyre under 18 years of age, they will also need parental

consent. If you have an accidents listed on your driving record, you may also be required to take either the written or onroad tests when you renew. Additionally, you will also be required to repass both tests if your drivers license has expired and you want to renew it. Drivers over the age of 75 are also required to take the onroad test when renewing their license. If you fail the test 3 times or do not pass it within the 12 month period, then you must submit a new application for your license and pay any required fees again. If you are under 18 years of age you must also have parental consent. However, applicants who are over the age of 18 and present a completion card from and Illinois Department of Transportation IDOT Motorcycle Rider Course do not have to take the onroad test. Additionally, boaters also have the option of taking an online safety course offered by either BoatEd.com or BoaterExam.com. The minimum age to receive the certificate is 12, but boaters under 18 must be accompanied and directly supervised by an adult or person holding a Boating Safety Certificate. Choosing to proceed in this manner, however, will usually result in a conviction on the drivers record for the citation. Some drivers may desire a court hearing in order to work out a more acceptable negotiated plea. Furthermore, court appearances are mandatory for certain traffic offenses, including driving under the influence DUI, reckless driving, and operating a vehicle without a valid drivers license. Other violations drivers may commit include disobeying the Child Passenger Safety Act; DUI; drag racing; reckless driving; leaving the scene of an accident where property damage, injury or death is involved; fleeing to elude police; and failing to wear a seatbelt while driving. Illinois also recently passed a law prohibiting texting or using a cell phone in any way while driving.
