Papers have been filed with the state attorney general seeking a signature drive to qualify as a ballot measure in the November 2020 election. California tribes through the Coalition to Authorize Sports Wagering have submitted 1.4 million signatures to the state to place a sports betting measure on the Nov. 8, 2022 ballot.
