Philippine offshore gaming operators (POGOs) are online gambling companies that operate in the Philippines but offer their services to customers outside of the country.

Since liberalizing rules in 2016, the Philippines rapidly developed as a massive hub for online gambling, especially as a strategic base for firms to target customers in China. At their height, Philippine offshore gambling operators (yep, POGOs) employed over 300,000 workers who came over from China. Wanting a piece of the action, especially to recuperate revenue lost during the pandemic, the government raised taxes and introduced tighter regulations, which ultimately pushed many firms abroad.

POGOs operate online casino games from inside the Philippines. The interactive gaming platforms are prohibited to allow Filipinos access to the sites. Instead, the gambling platforms exclusively cater to foreign countries.

# Casino pogo philippines online

The following year, tighter regulations added to POGOs' woes. Manila imposed a 5% tax on gross gaming revenue and charged foreigners employed in online casinos and their service providers 25% income tax. The government hoped to raise tax revenue, but in reality, it drove many POGOs out of the country.

POGOs are online gaming companies licensed to operate in the Philippines. They offer a variety of gaming services including online casino games and sports betting to foreign gamblers.

The Philippines justice department ordered the shutdown of 175 online casinos which were operating illegally and has ordered the deportation of 40,000 Chinese workers.

The gaming corporation regulates all elements of the Philippines gaming industry, including commercial land-based casinos, POGOs and VIP iGaming. PAGCOR additionally operates its own casinos under the Casino Filipino brand.

The sector emerged in the Philippines in 2016 and grew exponentially, as operators capitalised on the country's liberal gaming laws to target customers in China, where gambling is banned.

China's embassy in Manila in a statement said Beijing supports the deportation and crackdown on POGO-related crimes, adding the government "firmly opposes and takes tough measures to combat gambling".

On May 4, 2022, PAGCOR received a letter from the Herrera Teehankee & Cabrera Law Offices informing PAGCOR of the Status Quo Ante Order (SQAO) issued by the Supreme Court in the case of Kazuo Okada vs. Tiger Resort, Leisure, & Entertainment, Inc. (TRLEI) et al., G.R. No. 256470.

In the meantime, Senator Grace Poe called for a "full-on probe on the social costs of POGOs" in the country to evaluate whether the country can still accommodate its operations. Poe announced she "would be filing a resolution on this immediately so that the chamber and the public can explore together its stance on POGOs once and for all."

In 2020, many of those businesses fled to neighboring countries like Cambodia, Vietnam, and Laos, as covid-19 ravaged the Philippines.
